The entry fee is refundable only upon cancellation of the competition by Stingray Cheer Co.

REGISTRATION FORM A: Please complete one Registration Form A per team. Enter a division based on participant age as of AUGUST 1, 2025. Please complete ALL areas of form.

REGISTRATION FORM B: Please complete one Registration Form B per team. Please include this form even if you choose not to participate in the contests or pre-order apparel (simply X out sections).

REGISTRATION FORM C: Please complete one Registration Form C per team. This completed Roster form MUST be sent in with your Registration Forms and Fee.

RELEASE WAIVER: We must have ONE waiver for EACH cheerleader competing. You may send these with your registration to emily@stingrayallstars.com, turn in to the front office at the Marietta gym, or bring them to "Cheerleader Check-In" the day of competition.

ENTRY FEES: See Registration Form A for all fee and deadline info.

Confirmation: You will receive confirmation of your registration via email. Please check our website Jams.StingrayAllstars.com and follow us on X (Twitter) @TheStingrayJams for further info and updates.

DIVISION INFORMATION:

Division Entry: Please base division entry on participant age as of AUGUST 1, 2025. Divisions are listed on REGISTRATION FORM A. Note: Divisions may be split or combined depending on the number of teams registered.

Division Eligibility: Due to the fact many Rec. programs need to combine teams to compete, we ask that 75% of your team be of age to register in a division. Take the number of athletes on your team and multiply by .75. The answer is the number of girls that need to be of age, or younger, to register in that division. MIDDLE SCHOOL teams: 100% of your team must be of age or younger to compete in a division.

COMPETITION INFORMATION:

Routine Length: Each team will be given a max of 2 minutes and 30 seconds to perform their routine.

NOTE: MAX ROUTINE LENGTH FOR SIDELINE DIVISIONS IS 2:00.

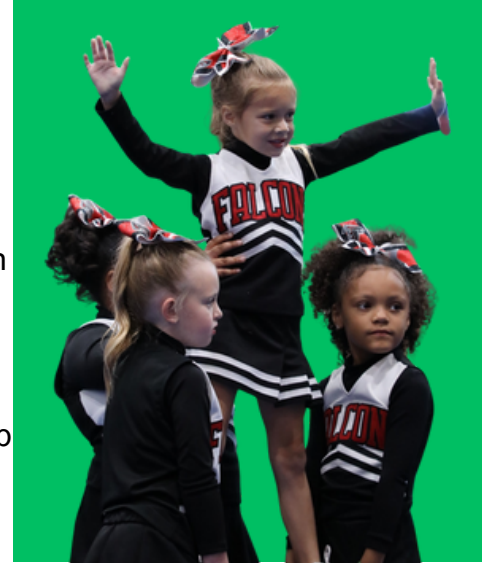
All or part of the routine may be performed to music. Timing will begin with the team's first movement or sound, and end with the last movement or sound.

Music: Music can be played from an phone, iPad, or MP3 player (NO CDs). We will provide a system in which to play your music in the warm-up room and in the competition area.

Rules and Regulations: Please be sure all coaches have a copy of The Jams Rules and Regulations. It is included in this packet on page 10.

Performance Floor: Teams will perform on a competition size mat (9 strips, 54x42). There will be NO deduction for stepping off the mat.

Judges and Score Sheets: A panel of knowledgeable judges will evaluate team performance. The Head Judge's score will be used to decide placement in the event of a tie. Score sheets will be available at the announcer's table immediately following your Award Ceremony.



AWARDS

Individual Awards will be given to ALL competitors!

- Halloween Jam: 1st place winners receive a team banner. 1st, 2nd, and 3rd place winners all receive medals.
- Circus Jam: 1st place winners receive a team banner. 1st, 2nd, and 3rd place winners all receive medals.
- Grand Champion Team Trophies Awarded to the team with the highest overall score.
- Our coveted SPIRIT and SPORTSMANSHIP Trophy Awards will be handed out at each Award Ceremony to Associations showing the Most Spirit and the Most Sportsmanlike behavior!

COMPETITION INFORMATION CONTINUED:

Jump-off: Each participant will show 2 different and non-connected jumps. All teams may register up to 4 cheerleaders for the Jump-off competition. The Jump-off divisions are Middle School, Tiny/Mini, Youth, Minor and Junior/Senior. 1st, 2nd and 3rd place winners will be recognized at their awards session and receive a medal! The Jump-off is Pre-Registration ONLY. **No changes** may be made to Jump-off entries after the final registration date, including day of event. (\$10/jumper) FINAL DEADLINE TO REGISTER IS OCTOBER 10TH (Halloween Jam) & OCTOBER 24TH (Circus Jam).

Lib-off: Open to Middle School only (sideline or comp). A contest to see which stunt group can hold their flyer in an extended, lib position for the longest... Last group standing is our winner! All Middle School Lib-off teams will compete together in one division. A lib-off ticket is \$25 per group with a max of 5 athletes per group, Front spots welcome! FINAL DEADLINE TO REGISTER IS OCTOBER 10TH (Halloween Jam) & OCTOBER 24TH (Circus Jam).

Tumble-off: Each participant will show their BEST RUNNING PASS. All teams may register up to 4 cheerleaders for the Tumble-off. The Tumble-off divisions are Middle School, Tiny/Mini, Youth, Minor and Junior/Senior. 1st, 2nd and 3rd place winners will be recognized at their awards session and receive a medal! The Tumble-off is Pre-Registration ONLY. **No changes** may be made to Tumble-off entries after the final registration date, including day of event. (\$10/tumbler) FINAL DEADLINE TO REGISTER IS OCTOBER 10TH (Halloween Jam) & OCTOBER 24TH (Circus Jam)

PARTICIPANT AGREEMENT

As parent or legal guardian of _____, a minor ("Minor"), and in consideration for Minor's participation in the cheerleading, dance and other activities and services, including, without limitation, travel to and from such activities, competitions, conferences, meetings, and other events that may require travel (collectively, the "Activities"), conducted and provided by STINGRAY CHEER COMPANY, INC., a Georgia corporation; STINGRAY SPORT CENTER, LLC, a Georgia limited liability company; STINGRAY BRANDS, LLC, a Georgia limited liability company, and their respective affiliated entities, owners, agents, officers, employees, representatives, and all other persons or entities acting in any capacity on their behalf (collectively, "SA"), I AGREE AS FOLLOWS:

I. Liability Release. ON BEHALF OF MYSELF AND MY HEIRS, ASSIGNS, EXECUTORS, AND ADMINISTRATORS, I RELEASE AND FOREVER DISCHARGE SA FROM ALL CLAIMS, JUDGEMENTS, LOSSES, LIABILITIES, DAMAGES, COSTS, AND EXPENSES (COLLECTIVELY, THE "CLAIMS") OF ANY NATURE ARISING OUT OF OR IN ANYWAY RELATED TO THE MINOR'S PARTICIPATION IN THE ACTIVITIES WHETHER OCCURRING ON THE PREMISES OF ANY SA LOCATION OR ANY OTHER LOCATION; I FURTHER AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS SA FROM AND AGAINST ANY AND ALL SUCH CLAIMS, INCLUDING, WITHOUT LIMITATION, ATTORNEYS' AND OTHER PROFESSIONALS' FEES AND COSTS. I understand that this release and discharge of Claims includes, without limitation, any Claims based on the negligence, action, or inaction of SA and covers personal and bodily injury (including death) and property damage, whether suffered by Minor before, during, or after participation in any Activities, and includes all Claims arising from the publication of use of any photograph, videotape, or narrative in any media. I acknowledge that SA makes no representations or warranties, either express or implied, regarding the condition or suitability of SA's or any other locations or equipment for the Activities. The laws of the State of Georgia shall govern this release and indemnity agreement.

II. Medical Release. I acknowledge and agree that Minor's participation in the Activities subjects Minor to the possibility of physical illness or serious injury (including death). I further acknowledge and agree that Minor is assuming the risk of such physical illness or serious injury (including death) by participating in the Activities. In the event of such physical illness or injury, I authorize SA to obtain necessary medical treatment for Minor and I release, hold harmless, and forever discharge SA from any Claims arising from or related to any physical illness or serious injury (including death) and to the exercise of this authority. I further acknowledge and agree that I will be responsible for any and all medical and related costs and expenses incurred by and on behalf of Minor for any such physical illness or injury.

III. Appearance Agreement. I understand that SA may from time to time produce promotional and other audio or visual materials and media relating to the Activities (the "Promotional Material"). I understand that, as a participant in or spectator of such Activities, Minor may be included in video recordings, audio recordings, photographs, and images taken during Activities for use in Promotional Material. THEREFORE, I HEREBY ASSIGN, TRANSFER, AND GRANT TO SA, WITHOUT RESERVATION OR LIMITATION, THE ROYALTY-FREE, EXCLUSIVE RIGHT TO USE SUCH VIDEO RECORDINGS, AUDIO RECORDINGS, PHOTOGRAPHS, AND IMAGES OF MINOR, AS WELL AS MINOR'S NAME, LIKENESS, PERSONAL AND DEMOGRAPHIC INFORMATION, VOICE AND APPEARANCE AS PART OF ANY PROMOTIONAL MATERIAL. IN GRANTING THIS LICENSE, I HEREBY WAIVE ANY RIGHT TO INSPECT OR APPROVE ANY SUCH PROMOTIONAL MATERIAL PRIOR TO PUBLICATION. I FURTHER AGREE THAT, UPON THE REQUEST OF SA, I SHALL IMMEDIATELY REMOVE OR TAKE DOWN ANY PROMOTIONAL MATERIALS THAT MINOR OR I HAVE UPLOADED OR POSTED TO ANY WEBSITE OR SOCIAL MEDIA PLATFORM (INCLUDING, BUT NOT LIMITED TO, FACEBOOK, TWITTER, INSTAGRAM AND YOUTUBE), OR IN ANY OTHER PUBLIC FORUM.

IV. Confidentiality. I acknowledge and agree that SA develops and creates unique and valuable proprietary dance routines, cheerleading routines, training techniques, and other intellectual property that are unique and valuable to SA and that may be used to prepare for and participate in competitive events (collectively, the "Intellectual Property"); I further acknowledge and agree that maintaining the confidential and proprietary nature of the Intellectual Property is of the utmost importance to SA and its competitive success. I understand that I may video-record, audio-record, photograph, or take other images of the Intellectual Property solely for my, Minor's, or Minor's immediate family's personal, non-commercial use; PROVIDED ALWAYS, HOWEVER, THAT MINOR AND I SHALL NOT POST OR UPLOAD ANY SUCH RECORDINGS OR IMAGES TO ANY WEBSITE OR SOCIAL MEDIA PLATFORM (INCLUDING, BUT NOT LIMITED TO, FACEBOOK, TWITTER, INSTAGRAM, AND YOUTUBE), OR IN ANY PUBLIC FORUM WITHOUT THE PRIOR WRITTEN CONSENT OF SA.

V. Breach. I ACKNOWLEDGE AND AGREE THAT ANY BREACH OR THREATENED BREACH OF SECTION IV OF THIS AGREEMENT WILL CAUSE SA IRREPARABLE INJURY FOR WHICH NO ADEQUATE REMEDY AT LAW IS AVAILABLE AND I CONSENT TO THE ISSUANCE OF AN INJUNCTION PROHIBITING ANY CONDUCT VIOLATING THE TERMS OF SECTION IV. I ACKNOWLEDGE THAT ANY VIOLATION OF THIS AGREEMENT BY MINOR OR BY ME MAY RESULT IN MINOR BEING SUSPENDED FROM OR PERMANENTLY EXPELLED FROM PARTICIPATION IN SOME OR ALL ACTIVITIES AND MY SUSPENSION FROM ATTENDING AND SPECTATING SOME OR ALL ACTIVITIES. I ACKNOWLEDGE THAT IN ANY CASE WHERE MINOR IS SUSPENDED OR PERMANENTLY EXPELLED FROM PARTICIPATION IN SOME OR ALL ACTIVITIES, I WILL NOT BE ENTITLED TO ANY REFUND OF ANY AMOUNTS PAID FOR PARTICIPATION IN ANY CURRENT OR FUTURE ACTIVITIES.

THE STINGRAY JAMS GENERAL RULES AND SAFETY REGULATIONS

General Rules

1. The Stingray Jams are competitions hosted for middle school affiliated teams and recreational squads. Allstar programs are welcome to participate by exhibition only.
2. Jewelry of any kind is prohibited. This includes earrings, nose, tongue and belly button rings, necklaces, and pins on uniforms.
3. Use of glitter is permitted.
4. Mascots may not participate in stunts, pyramids, or tosses and may not serve as a spotter during the performance.
5. Only the following props are allowed: signs, poms, banners, flags, and megaphones. Flags and/or banners with poles or similar support apparatus may not be used in conjunction with a stunt or tumbling. Electric signs are prohibited.
6. Routine time limit: 2 minutes and 30 seconds. (SIDELINE ROUTINES are limited to 2 minutes.) All or part of the routine may be performed to music.

General Safety

1. Use of mini-tramps, springboards, or any apparatus used to propel a participant is not permitted.
2. Drops (knee, seat, thigh, front, back and split drops) from a jump, stand or inverted position are prohibited unless the majority of the weight is first borne on the hands/feet in order to break the impact of the drop.
3. We will **NOT** supply spotters. You may supply your own spotters if you wish.

Tumbling

1. Tumbling over, under, or through a stunt, individual, or prop is not permitted. Exception: Forward or backward roll over a prop.
2. Tumbling "with" a prop is illegal. (Example: back handspring with poms is illegal.)
3. All tumbling must originate from and land on the performance surface.
4. Spotted, assisted, or connected tumbling is prohibited. (Example: toe pitches, double cartwheels and chorus line flips are illegal.)

Partner Stunts/ Pyramids/Cradles

1. All stunts or pyramids are limited to two persons high.
2. When tossing a flyer from one stunt to another, one of the initial main bases must always stay in contact with the flyer.
3. Cradles at prep level or above must have a total of 3 catchers. A back spot must be positioned at the head and shoulder area through the cradle.

Tosses (Basket and Squish)

1. Tosses must be performed from ground level and must land in a cradle position.
2. Top person must be caught in a cradle position by 3 original bases one of which is positioned at the head and shoulder area of the top person.
3. Flipping tosses are prohibited.
No stunt, pyramid, individual, or prop may move over or under a toss, and a toss may not be thrown over, under, or through stunts, pyramids, individuals, or props.

Deductions (MIDDLE SCHOOL SIDELINES/REC DIVISION)

- 3 Points (per occurrence) for each general or safety rule violation.
- 3 Points (per occurrence) for an additional spotter assisting a stunt or cradle.
- There is NO out of bounds penalty.


Deductions (MIDDLE SCHOOL COMP DIVISION ONLY)

- .25 Points per occurrence for an athlete tumble bust. A tumble bust is defined as:
 - hand/s or head down in tumbling
 - knee/s down in tumbling
 - only feet can land on mat at completion of skill. Tripping during a transitional element will not be a deduction.
- 1 Point per occurrence for a building fall. A building fall is defined as:
 - unchoreographed drops to a cradle, load-in, prone position.
 - multiple bases/spotters drop to performance surface.
 - top person lands on base/and or spotter, who drops to performance surface.
 - top person lands on performance surface un-braced
- 3 Points per occurrence for each general or safety rule violation. There is not an out of bounds penalty.
